## SERVICE AGREEMENT

This is a contract between Augusta Farley/Best Friends Pet Resort and the pet owner whose signature appears below (hereinafter called "Owner").

Augusta Farley/Best Friends Pet Resort shall not be liable for sickness or injury suffered while the animal is boarded, groomed, trained, or in transit to and from the kennel. The Owner authorizes Augusta Farley/Best Friends Pet Resort to engage a veterinarian to treat the animal whenever it is deemed reasonably necessary and the Owner by signing below guarantees payment of any and all veterinary fees. The Owner authorizes Best Friends Pet Resort to administer Capstar and/or a monthly flea and tick remedy if fleas or ticks are observed or suspected and the Owner by signing below guarantees payment of the retail price.

If and when boarding charges are delinquent 15 days, Augusta Farley/Best Friends Pet Resort may dispose of the animal in such manner as she/it sees fit.

The Owner hereby agrees to waive, release, indemnify, and hold harmless, including payment of reasonable attorney fees, Augusta Farley/Best Friends Pet Resort and its employees from any all liability of any nature for any loss, injury, damages or expense the Owner may suffer or bear as a result of any happening or event at the facility during the time when the animal was present at the facility, including damage or injury resulting from the action of any dog, or during the time when the animal was in transit to and from the facility.

Any disputes between Owner and Augusta Farley/Best Friends Pet Resort may be arbitrated by **the American Arbitration Association**, upon decision of Best Friends Pet Resort, and said arbitration shall be binding on both parties.

This agreement constitutes a bailment with all the legal ramifications thereof.

If the Owner signs as the agent, by signing he guarantees that he has authority to sign this document and that he will become personally liable for all expenses for lodging, training and grooming, veterinary fees and other expenses reasonably incurred by Augusta Farley/Best Friends Pet Resort during the time the animal is on the premise, or in transit to and from the kennel.
